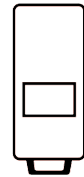

Product Description

Product Properties

Examples of non-aqueous working materials are:
Oils, greases, lubricants, cast iron and graphite dusts, paints, varnishes, adhesives, soot, tar, bitumen, etc.

Application

Carefully rub DIRT PLUS into clean, dry skin (including the nail bed) before work. Dirt can be washed off with water (and some hand cleanser if necessary). Reapply the skin protection every time after washing your hands.

Certificate of Dermatological Compatibility

The dermatological compatibility of REGENT DIRT PLUS has been carefully tested and proven. A printed certificate is available.

Ecology

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

Statutory Regulations

REGENT DIRT PLUS is subject to the Regulation (EC) No 1223/2009 on cosmetic products. Further details on handling the product can be obtained from the Group Data Sheets for skin products (for occupational use).

Storage Instructions

The product can be stored in original sealed containers at room temperature for at least 30 months (from the date of manufacture). Shelf life after first opening (PAO, Period after Opening) is indicated on the packaging.
